Crosby talked about the Groundwater monitoring agreement that needs to be discussed and signed. Council requested to have a meeting with Dave Albisser about the regional Landfill agreement next week if possible.

### **Councillor Activity Reports**

Councillor T. Wheeler attended the FCM meeting in Quebec at the end of May and missed the regular meeting on June 4<sup>th</sup>, 2019.

She attended the LSCFN GA last weekend. There were a lot of discussions about the sewage lagoon site, but a final consensus on the proposed location area.

YG provided a community dinner and facilitated discussions about the lagoon on June 10<sup>th</sup>.

LSCFN and VOC still have questions about the lagoon and will discuss that at the next joint council meeting.

Councillor Wheeler attended the language training and she thinks it is good to bring that up here to Carmacks.

Councillor L. Graham attended the Lagoon presentation on June 10<sup>th</sup>, 2019. She thinks the location at the Mt. Freegold Road would be great.

Councillor G. Skookum has not much to report. The discussion about the lagoon has to continue and the VOC and LSCFN has to work together on this.

He talked about the issue with the Recycling Society, we need to find a replacement for Carla.

Councillor Skookum just came back from the meeting with Shae Thomas, organizer of the Wall of Fame at the Rec-centre. He talked about the history of the Village and people that should be included on the wall and offered some contacts.

### **Mayor Report**

Mayor Bodie was not able to attend the LSCFN GA due to being busy at work.. He went to a meeting with the Assistant Deputy Minister of Immigration Yukon. The biggest problem here in the Yukon is to find housing for employees.

### **CAO Report**

CAO T. Thomas provided report and broke it down verbally.

Council discussed waste management proposal and will clarify at the meeting with Dave Albisser.

### **Rec-Centre Report**

Council read report.

Sherry Whittle has submitted her resignation as the Recreation Director, and they are moving back to Newfoundland. The job has been posted.

#### **Recycling Depot**

Mayor Bodie informed council about resignation from Carla Gage, Recycling Depot manager and Bev Brown. The job is posted, and we hope that we find someone

soon so that the depot is not closed. Maybe send out tender to local contractors that would want to take over the position.

#### Coal Mine Campground

Council discussed issue with Coal Mine Campground and landfill hours and came to the conclusion that the owner of the property is responsible for the proper storing and disposal of garbage (see Wildlife Act).


Because of the Yukon River Quest going on next week, council will make an exception that Dale would be allowed to dispose of his garbage at a certain time during closing hours of the landfill.

CAO T. Thomas is going to draft up a letter to the campground informing owner of council decision.
