# **Village of Carmacks Housing Development Grants**

Instructions to Prospective Applicants September 5, 2025



#### Overview

The following instructions are intended to support prospective applicants through the Fall 2025 Housing Development Grant intake process. The intake will formally start on Monday, September 5<sup>th</sup> at 4:00 p.m. and end on Wednesday, October 8<sup>th</sup>.

### How do I get started?

Please review Section 3.0 of the Eligibility Housing Development Grant Policy (available online at <a href="www.carmacks.ca/housing-grant">www.carmacks.ca/housing-grant</a> or at the Village of Carmacks office) to ensure that you/your organization meets the criteria for the grant. Applicants should also review the remainder of the policy to ensure they understand what will be expected of them if they are successful in receiving a grant.

We strongly encourage applicants to confirm their eligibility before proceeding with their application. For Minor grants, applicants need to fill out and submit the application form. There is no application form for Major grants; instead, applicants should email the Village at cao@carmacks.ca to confirm in writing that they would like to initiate discussions and work towards a draft funding agreement with the Village.

## How can I submit my application for a Minor Grant?

You may submit your application via email or in hard copy to the Village (see contact informationa above). All required documents must be submitted at the same time (in electronic or hard copy form).

### What if I can't meet the intake deadline?

Depending on the number of applications received, there may still be money left after the October 8<sup>th</sup> deadline and applications will be processed on a first-come, first-serve basis.

## What other agencies might I need to talk to?

Depending on the nature of your project, you may need to reach out to a Government of Yukon (YG) branch that issues approvals. If you are developing a rental unit or drilling a well, additional financial assistance may be available through other programs. Don't miss out on other potential funding and/or financing opportunities!
